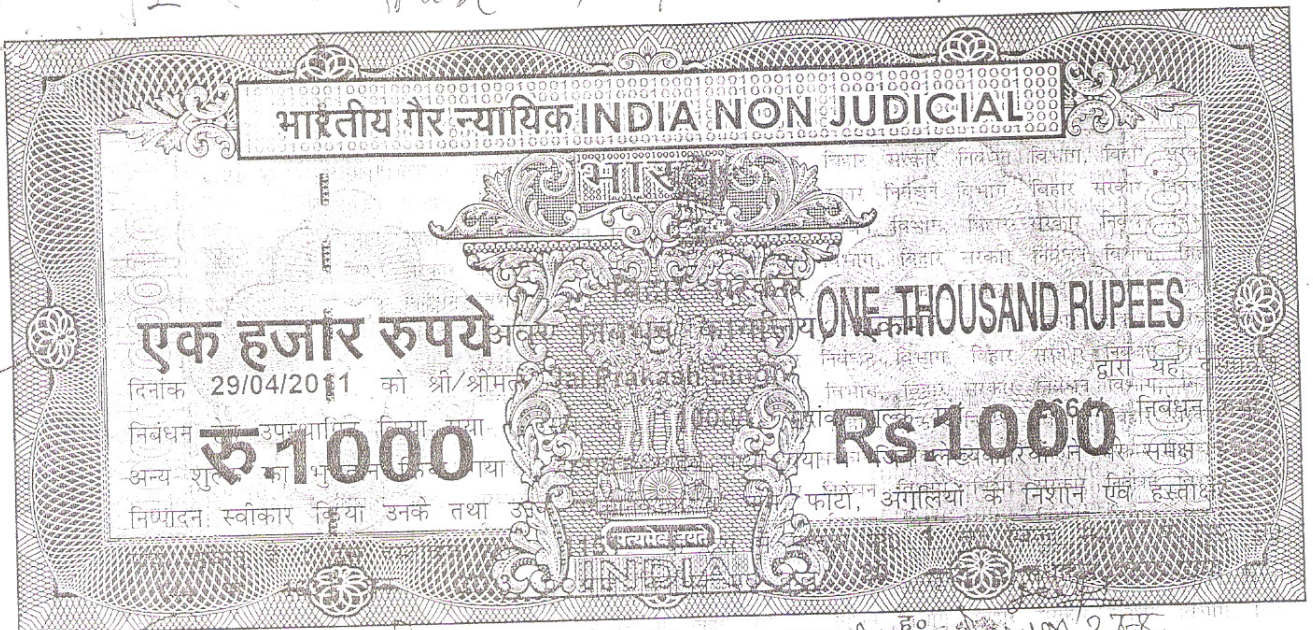

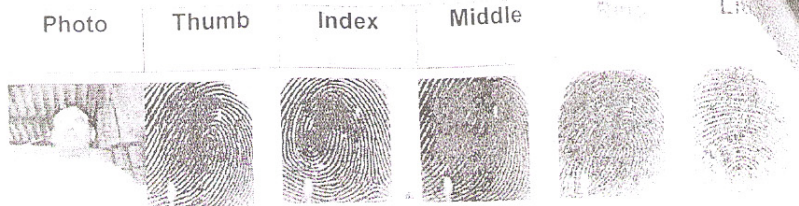

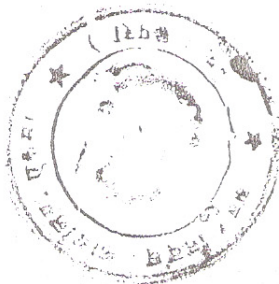

Subject to the terms and provisions declared hereby and confirmed by the TRUSTEES.

**NOW THIS INDENTURE WITNESS AS FOLLOWS :**

1. **TRANSFER:**

That the SETTLER is the absolute owner of a sum of Rs. 50,000 (Rupees Fifty thousand only) and hereby conveys, transfer and grants into the hands of the TRUSTEES named herein above to hold the same for the said Trust to carry out the objects and purposes and for wishes of the SETTLER accordingly to the direction herein below.

2. **NAME :**

That the name of the trust be "BAPUJI EDUCATIONAL & DEVELOPMENT TRUST."

3. **OFFICE OF THE TRUST :**

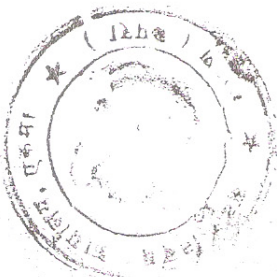
That the office of the trust shall be situated at :

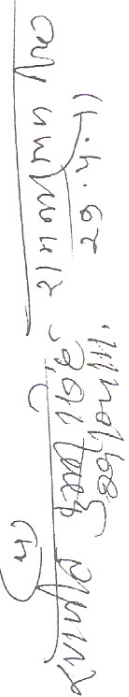

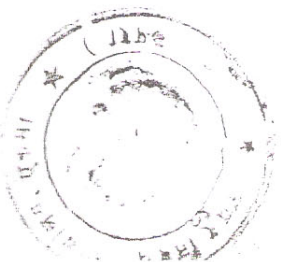

- ii) Establishment and support of professorships, fellowships, Lectureships, scholarships and prizes at schools, colleges or other Educations, Institutions.
- iii) Establishment and maintenance of Hostels and/or Boarding for Students and Trainers.
- iv) Grant or Endowments at universities, Research Institutions and other Education and Scientific Institutions for spread of Education and knowledge in all or any branches.
- v) Establishments and maintenance of sports centers and providing education and training in sports of all types.
- vi) Establishment, maintenance and support of libraries, laboratories, research & design centres and reading rooms for advancement of education and knowledge in general.
- vii) To setup Educational Institution for informal education, Management colleges, colleges for technical education and other professional educational colleges.



- viii) Establishment of Institution related to environmental activities, games and sports. (1)
- ix) Establishment and maintenance of institution related to web development software developer and other computer related objects.

6. The Trustees shall in case where any aid is proposed to be given for charitable purposes to any individual institutions, associations, society, organization, body or trust ascertain whether the objects of such institution, association, society organization body or trust are in accordance with the objects of this trust and if so satisfied may donate to such individual institution, association, society, organization body or trust for being utilized only for such objects.

#### MANAGING TRUSTEE :

**JAI PRAKASH SINGH** shall be the Managing Trustee for the life time of this Trust, who shall, subject to the control and Supervision of the Trust, look after the day-to-day affairs and administration of this Trust. In case of vacancy TRUSTEES may nominate/ elect a Managing Trustee from amongst them, and may fix the period and terms of this office.

7. TRUSTEE :





- (a) The number of the TRUSTEES shall not be less than two and more than seven, If the number of the TRUSTEES falls below two, the remaining TRUSTEE shall not act on behalf of the Trust except for the purpose of filling up a vacancy, as long as the number of TRUSTEES is below the minimum.
- (b) The TRUSTEE will be at liberty to appoint additional TRUSTEE(S) within the number mentioned above.
- (c) Except for the initial The TRUSTEE, who shall cease to be a TRUSTEE only on death or through voluntary resignation, a TRUSTEE shall cease to hold office if he or she :
- Absents without leave.
  - does not attend three consecutive meetings of the Trust or fails to attend meetings for one calendar year, whichever is longer; or
  - is requested to resign by 2/3<sup>rd</sup> of the TRUSTEES or as near to this number as possible of the remaining TRUSTEES.
- (d) Any TRUSTEE is at liberty to resign from the TRUST on giving one months prior notice in writing of his or her intention to do so.



- (e) The TRUSTEES shall be responsible only for such moneys, stocks, shares and funds as shall actually come into their hands. A TRUSTEE shall not be answerable to or accountable for the neglect, default or acts of omission or commission of the other TRUSTEE(S) or of any banker or other person with whom the Trust properties or funds or any securities may have been deposited or kept.

#### 8. POWER OF THE TRUSTEES :

- (a) The TRUSTEES shall be at liberty, at their absolute discretion to accept any property, contributions, grants, collection or donations from persons, firms, companies or government or other institutions, including foreign agencies/ institutions or foreign governments, for the advancements of the objects of the Trust.
- (b) The TRUSTEES shall be entitled from time to time to open and maintain bank accounts in the name of the Trust with a bank or banks, to operate such account(s) and to give instructions to the bank(s) and to provide for opening and operation of such account(s) by the **JAI PRAKASH SINGH** with any one amongst remaining trustees authorized by a resolution passed by a meeting of trustees.





- (c) The TRUSTEES may borrow or raise moneys or funds from banks, financial institutions, government, other institutions, persons, firms and companies for the purpose and the objects of the Trust, on such terms and conditions as they may think fit in the interest of the Trust and mortgage, pledge or otherwise secure all or any of the properties or investments of the Trust as a security against such borrowings.
- (d) The TRUSTEES shall be at liberty to sell and/or realize the Trust Property, if and when acquired, in future or funds and invest the sale proceeds thereof or any other moneys, being part of the Trust Fund, in any manner as the TRUSTEES may from time to time think fit, within the scope of this Trust and within the scope of law.
- (e) The TRUSTEES may invest money either with or without security.
- (f) The TRUSTEES may set apart any part of the income of the TRUST for spending in future for any of the objects of the Trust in accordance with the provisions of the law including the income tax law applicable for the time being.

- (g) The TRUSTEES may create a Corpus Fund out of any specific grant or donation or out of the income of the Trust and invest the same in suitable long term investments and may out of the corpus of the Trust spend such money or out of the sale proceeds or any part thereof appropriate such money or part thereof for all or any of the charitable objects, and purposes of the Trust. (12)
- (h) The Managing Trustees or the TRUSTEES may engage regular, permanent part-time or honorary staff, if necessary and according to the requirement for managing or working of the Trust and use the Trust funds for payment of their salaries, compensation, expenses, etc. (23)
- (i) The TRUSTEES may let or hire out any movable or immovable properties belonging to the Trust for such period and at such rent or charge and on such terms and conditions as the TRUSTEES in their discretion may think fit in the interest of the Trust. (24)
- (j) The TRUSTEE may, subject to the provisions of law, contribute to the funds of any professional association, individual, firm, corporate body, society, organization or institution, which in the opinion of the TRUSTEES is beneficial to the Trust. (25)





(k) The TRUSTEE may conduct workshops, conferences, seminars, meetings, forms, symposia and create opportunities for medical professional, researches, scholars, technicians and interested persons to meet regularly to exchange views, notes, research findings and inventions and to publish newspapers, books, magazines, periodicals and/or leaflets related to the aims, objects and purposes of the Trust.

(l) The TRUSTEES may reimburse themselves for all expenses actually incurred or spent by them in connection with the Trust or affairs of the TRUST or their duties relating thereto.

(m) The TRUSTEES may join, co-operate or amalgamate this Trust with other or others having allied objects, upon such terms and conditions as the TRUSTEES may in their discretion think fit, particularly having regard to and in conformity with the aims and objects and nature of the Trust.

(n) The TRUSTEES may institute, defend, adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding the Trust property or the Trust funds.

(o) The TRUSTEES may engage constituted attorney(s) or agent(s) and to delegate to such attorney(s) or agent(s) all or any of the powers vested in them under this Trust Deed and from time to time remove such attorney(s) or agent(s) and to engage other or others in his or their place(s).

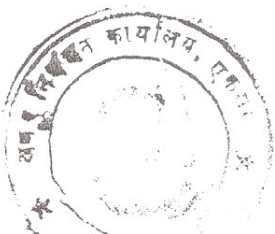
(p) The TRUSTEES have power to frame rules and regulations to carry out and to give effect to the objects and the purposes of the Trust and/or Managing the affairs of the Trust and to alter, and/or amend the same from time to time.

(q) The TRUSTEES may do any other thing or things which is/are incidental and conducive to the attainment of the aims and objects or any one of them.

#### 9. MEETINGS:

(a) The Managing Trustee for the time being shall be authorized to call a meeting of the TRUSTEES by giving notice in writing or orally to the other TRUSTEES.

(b) A quorum for a meeting of the TRUSTEES shall be  $\frac{2}{3}$ rd of the existing no. of trustees.

- (c) All matters will be decided mutually by the TRUSTEES or by the majority of the TRUSTEES at a meeting convened for that purpose.
- (d) Resolutions may be passed without holding a meeting of the TRUSTEES by circulating in writing the proposed resolutions, which must be endorsed by two-thirds of the TRUSTEES. If resolutions are endorsed in this manner, they shall be as valid and effectual as resolutions passed at a meeting of the TRUSTEES.
- (e) The TRUSTEES shall keep or cause to be kept a minute book of the proceedings of the meetings.
- (f) The TRUSTEES may, if so decided unanimously, dissolve the Trust and transfer the Trust and/or such part of portion thereof, as shall, for the time being remain in the hands of the TRUSTEES, or the investment and properties of the Trust or a part thereof to any other institutions or trust for pursuing the objects specified, but no part of the Trust funds, assets or liabilities shall be transferred to the SETTLER or any of the TRUSTEES at any time or under any circumstances, upon dissolution.



10. **FINANCE & ACCOUNTS :**

- (a) It shall be lawful for the TRUSTEES to settle all accounts and to compromise, compound, abandon or refer to arbitration any action or proceedings or dispute, claim, demand or things, proper for such purpose without being responsible for any loss occasioned thereby.
- (b) It shall be lawful for the TRUSTEES to borrow money either on the security of any property belonging to the Trust or otherwise, to fulfil any or all of the aims and objects of the Trust, and it shall be lawful for the TRUSTEES to make this borrowing and the payment of any interest that may result, on such terms and conditions as they think fit.
- (c) It shall be lawful for the TRUSTEES to apply to the government, foreign body/person, public bodies, urban, local, municipal, district and other bodies, Corporations, companies or persons for and to accept grants of money, aid, donations, gifts, subscriptions and other assistance with a view to promotion the aims and objects of the Trust and to discuss and negotiate with the government departments, public and other bodies, corporations, companies or persons, schemes and other works and matters within the aims and objects of the Trust.

(d) The TRUSTEES shall cause true and accurate accounts to be kept of all money received and spent and of all matters in respect thereof in the course of the management of the Trust property or in relation to the carrying out of the aims and objects of the Trust as well as of all assets, credits and effects of the Trust property. (2)

(e) The accounting year of the Trust shall be financial year, that is year ending 31<sup>st</sup> March every year. (3)

(f) The accounts of the Trust shall be audited every year by a firm a Chartered Accountants, engaged by the TRUSTEES. (4)

#### 11. APPLICATION OF TRUST PROPERTY/INCOME :

(a) It is expressly declared that no part of the Trust Property or income of the Trust shall be applied for any purpose outside India of for any purpose which is not a public charitable purpose in law and all provisions hereof shall be construed accordingly. (5)

(b) The Trust property and the Trust Fund shall be and remain irrevocable for all time. (6)



12. JURISDICTION :

- (a) The Trust shall be authorized to function throughout India.
- (b) Should any legal disputes, claims or litigation within the jurisdiction of the law arise, they will only be considered valid if they are lodged within the precincts of the city of Patna.
